SCOPE OF WORK

The Department of Property and Procurement is seeking to enter into a Public Private partnership with regards to the repair and maintenance of Government Vehicle fleet in the U.S.V.I Territory.

The government will provide the motor pools and some government furnished equipment (GFE) shops engaged in the business of repairing motor vehicles that are owned by the government of the Virgin Islands.
