

FIRST AMENDMENT OF PROFESSIONAL SERVICES CONTRACT

THIS AGREEMENT made as of the 4th day of November, 2016 in the Territory of the Virgin Islands, by and between the **GOVERNMENT** of the Virgin Islands **DEPARTMENT OF PROPERTY AND PROCUREMENT**, on behalf of the **Office of Management and Budget (VIOMB), Department of Finance (VIDOF), Department of Education (VIDE), Department of Health (VIDH) and the Department of Human Services (VIDHS)**, (hereinafter referred to as "GOVERNMENT") and **Bazilio Cobb Associates, PC** (hereinafter referred to as "CONTRACTOR").

WHEREAS, the Contract expires /expired pursuant to its terms on **September 30, 2016**; and

WHEREAS, the parties desire to amend the Contract for six (6) months. This contract extension period for the services shall be effective from **October 1, 2016 and conclude March 31, 2017** upon the execution by the Governor of the Virgin Islands.; and

WHEREAS, the extension of the Contract pursuant to this Amendment of Professional Services Contract shall not result in any change to the scope of work provided for under the Contract and shall not require an increase to the compensation originally provided for under the Contract.

NOW THEREFORE, for mutual and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:
