**AMENDMENT No. 1 OF  
PROFESSIONAL SERVICES CONTRACT**

**THIS AMENDMENT** made as of the 29 day of November, 2019 in the Territory of the Virgin Islands, by and between the Government of the Virgin Islands **DEPARTMENT OF PROPERTY AND PROCUREMENT**, on behalf of the DEPARTMENT of EDUCATION located at 1834 Kongens Gade, St. Thomas, U.S. Virgin Islands, 00802 (hereinafter referred to as "Government") and **LIFT Education, LLC** of 156 Vinings Lake Court, Mableton, GA 30126 (hereinafter referred to as "Contractor").

Both parties witness to being duly authorized to execute this agreement and will attest accordingly when and where necessary.

**WITNESSETH**

**WHEREAS**, pursuant to Contract No. P026DOEC19 approved by the Governor on April 15, 2019 (which constitute and are hereinafter referred to as the "Contract"), the Government contracted with Contractor to provide instructional leadership training to school teachers aspiring to become school leaders/administrators; and

**WHEREAS**, the Contract expires pursuant to its terms on **November 30, 2019**; and

**WHEREAS**, the parties desire to amend the Contract, to extend its term by one (1) year, to change the Scope of Work in Addendum I to include an additional five (5) days of summer institute and four (4) days of virtual coaching, and to increase the compensation by **Forty-Three Thousand, Eight Hundred Dollars and Zero Cents**; and

**NOW THEREFORE**, for mutual and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

**TERMS AND CONDITIONS**

1. The Contract, is hereby amended and its term extended by one (1) year by deleting all existing language contained in Paragraph 2 and replacing it with language as follows:

"This contract shall commence upon the execution of the Commissioner of the Department of Property and Procurement and shall terminate on November 30, 2020."

2. Paragraph No. 3 – Compensation is hereby amended to increase the compensation by **Forty-Three Thousand, Eight Hundred Dollars and Zero Cents (\$43,800.00)** for a total amount not to exceed **One Hundred Forty Seven Thousand, Eight Hundred Dollars** and

Zero Cents (\$147,800.00) by deleting all of the existing language contained therein and replacing it with new language as follows:

“The Government, in consideration of the satisfactory performance of the services described in Addendum I (Scope of Services) agrees to pay Contractor the sum not to exceed One Hundred Forty-Seven Thousand Eight Hundred Dollars and Zero Cents (\$147,800.00) in accordance with the provisions set forth in Amended Addendum II (Compensation) attached hereto and made a part of this Contract.”

3. Addenda I and Addenda II of the Contract is revised by deleting all terms contained therein and inserting in lieu thereof all of the terms contained in the new amended Addenda I and amended Addenda II attached hereto as Exhibit “A”.

4. Paragraph No.16- Condition Precedent is deleted in its entirety and replaced with new language as follows:

“This Contract shall be subject to the availability and appropriation of funds and to the approval of the Commissioner of Property and Procurement.”

5. Paragraph No. 21 – Effective Date is deleted in its entirety and replaced with new language as follows:

“The effective date of this Contract shall be the day of execution of the Contract by the Commissioner of Property and Procurement.”

6. This Amendment is subject to the approval of the Commissioner of Property and Procurement and to the appropriation and availability of funds.

7. Except as expressly amended in this Amendment, all terms of the Contract remain in full force and effect.
