



**AMENDMENT No. 1 OF  
PROFESSIONAL SERVICES CONTRACT**

**THIS AMENDMENT** made as of the 29th day of November, 2019 in the Territory of the Virgin Islands, by and between the Government of the Virgin Islands **DEPARTMENT OF PROPERTY AND PROCUREMENT** on behalf of the **DEPARTMENT of Education** (hereinafter referred to as "Government") and American Institutes for Research in the Behavioral Sciences, Inc., whose address is 1000 Thomas Jefferson St., NW, Washington, DC 20007 (hereinafter referred to as "Contractor").

Both parties witness to being duly authorized to execute this agreement and will attest accordingly when and where necessary.

**WITNESSETH**

**WHEREAS**, pursuant to Contract No. P026DOET19 approved by the Governor of the Virgin Islands on March 27, 2019, (which constitute and are hereinafter referred to as the "Contract"), the Government contracted with Contractor to provide professional development training and job-embedded coaching to STEAM educators on the implementation of the Next Generation Science Standards ("NGSS") in the territory's public schools; and

**WHEREAS**, the Contract expires pursuant to its terms on November 30, 2019, and

**WHEREAS**, the parties desire to amend the Contract to extend its term by one (1) year, to change the Scope of Work in Addendum 1 to include additional support and professional development training to STEAM educators and administrators on Next Generation Science Standards and to increase the compensation by Sixty-Nine Thousand, Seven Hundred Ninety-Five Dollars and Zero Cents \$69,795.00, and *MRS*

**NOW THEREFORE**, for mutual and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereeto agree as follows:

**TERMS AND CONDITIONS**

1. The Contract is hereby amended and its term extended by one (1) year from November 30, 2019 by deleting all existing language contained in Paragraph 2 and replacing it with language as follows:

"This contract shall commence upon the execution by the Commissioner of the Department of Property and Procurement and shall terminate on November 30, 2020. The Government

in its sole discretion, shall have the option to renew this Contract for a period of one (1) additional year subject to the same terms noted herein, by providing the Contractor with sixty (60) days written notice of the Government's election to renew."

2. Paragraph No. 3 - Compensation is hereby amended to increase the compensation by Sixty-Nine Thousand Seven Hundred Ninety-Five Dollars and Zero Cents (\$69,795.00) for a total amount not to exceed Three Hundred Fifty-Two Thousand, One Hundred Fifteen Dollars and Zero Cents (\$352,115.00) by deleting all of the existing language contained therein and replacing it with new language as follows:

The Government, in consideration of the satisfactory performance of the services described in Addendum I (Scope of Services) agrees to pay Contractor the sum not to exceed Three Hundred Fifty-Two Thousand, One Hundred Fifteen Dollars and Zero Cents (\$352,115.00) in accordance with the provisions set forth in Amended Addendum II (Compensation) attached hereto and made a part of this Contract.

3. Addenda I and II of the Contract are revised by deleting all terms contained therein and inserting in lieu thereof all of the terms contained in the new Addenda I and II attached hereto as Exhibit "A".
4. This Amendment is subject to the approval of the Commissioner of the Department of Property and Procurement and to the appropriation and availability of funds.
5. Except as expressly amended in this Amendment, all terms of the Contract remain in full force and effect.
