- 1. The bid includes taser security guard services for the first time. What is the proposed environment for taser security guard service?
- 2. Will the Government accept armed security guard service in substitution of taser security guard service provided competitive rate?
- 3. Bid description #15 calls for "daily pick up of revenues for deposit to a banking institution". Please clarify if this is calling for the provision of armored car service. If so, is it in addition to existing armored car contracts in place with the Government or in substation of?
- 4. Bid description #13 directs that the Government "may accept any item in the bid". Please confirm that each location for each category of security guard service is a separate "item" of the bid.
- 5. Do bidders have the option to be physically present for the open bid?

- 3. The existing armored service contract is currently being utilized for this service. The User Agency in need of daily pick up of revenues for deposit to a banking institute will utilize the armored service contract currently in place. This contract will be for security guard services only.
- 4. One vendor will be awarded the contract in its entirety to include armed and unarmed taser services. The vendor who submits the lowest responsive responsible cost to the Government will be awarded the contract.
- The open bid will take place via conference call **only** by calling the number provided in the IFB documents. The bidder has the option to submit the bid package in person but unfortunately cannot attend the pre-bid due to circumstances surrounding the Corona Virus (COVID-19).
