





GOVERNMENT OF THE VIRGIN ISLANDS TASK ORDER CONTRACT Emergency Road Repairs <u>S38CDPWT21(RC)</u>

This Agreement made this <u>20th</u> day of <u>September</u>, <u>2021</u>, in the Territory of the United States Virgin Islands by and between the Government of the Virgin Islands (hereinafter referred to as "Government") on behalf of the Department of Public Works and **Rumina Construction**, LLC, whose address is **P.O. Box 308034**, St. Thomas, VI 00803 (hereinafter referred to as "Contractor"),

WITNESSETH:

WHEREAS, the Government is in need of a contractor to Provide Emergency Road Repairs for the Department of Public Works on the islands of St. Thomas and Water Island, U.S. Virgin Islands; and

WHEREAS, the Contractor was selected in accordance with RFQ-002-T-2021 (P); and

WHEREAS, the Contractor represents that it is willing and capable of providing the services in an expeditious manner and in accordance with the specifications cited in Addendum I and II; it is mutually agreed between the Parties as follows:

Section I. That for and in consideration of the prices and other terms and conditions of this Contract, the Contractor agrees to provide Emergency Road Repairs for the Department of Public Works on the islands of St. Thomas and Water Island, U.S. Virgin Islands to the Government. The Contractor shall furnishall necessary supplies to provide the services outlined in Addendum I (Scope of Work), attached heretoand made a part of this Agreement.

Section II. The Government in consideration of the satisfactory performance of the services described in Addendum I, agrees to pay Contractor in accordance with invoices submitted and approved by the Department of Public Works as set forth in Addendum II (Compensation) attached hereto and made a part of this Agreement.

Section III. This Contract shall commence on <u>September 15, 2021</u>, and shall terminate on <u>September 14, 2022</u>, unless mutually extended or terminated by the Parties. The services under this contract shall be for a period of <u>one (1) year</u> with a renewal option for a period of <u>one (1) year</u>. Section VII. This Contract constitutes the entire agreement between the parties hereto, and all prior understandings or communications, written or oral, with respect to the Service, which is the subject matterof this Contract, are merged herein.
