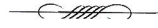

The Contractor will provide Pharmacy Benefit Management (PBM) services, including claims adjudication, coordination of benefits and point-of-sale processing services to eligible clients who are uninsured through the DHS Pharmaceutical Assistant Program (PAP) maintain a comprehensive distribution network of pharmacies; and provide reporting that meets client level data requirements of CMS. Eligibility determination services for all of the persons applying to VIPAP will be performed by the USVI DHS PAP staff. Contractor must have or be able to develop a mechanism to electronically receive and provide eligibility information that matches the data requirements of Health Resources and Services Administration (HRSA). The contractor will assist with formulary creation, maintenance and revision, every two years pursuant to HRSA requirements, and rebate management services. The contractor will also be expected to facilitate quarterly formulary advisory committee meetings to provide guidance on medication trends, and formulary updates. All the terms, covenants, and conditions of the contract affected shall continue in full force and effect.




