



# AMENDMENT No. 1 OF

# SUPPLY CONTRACT NO. S054BDPWC21(CTS)

THIS AMENDMENT made as of the <u>19th</u> day of <u>April</u>, 2022 in the Territory of the Virgin Islands, by and between the Government of the Virgin Islands **DEPARTMENT OF PROPERTY AND PROCUREMENT**, on behalf of the **DEPARTMENT OF PUBLIC WORKS** (hereinafter referred to as "Government") and <u>Allan G. Chitolie dba Chitolie</u> <u>Trucking Services</u> whose address is <u>Plot 2 & 4 Cassava Gardens, Christiansted, VI 00820</u> (hereinafter referred to as "Contractor").

#### WITNESSETH

WHEREAS, pursuant to Supply Contract No. <u>S054BDPWC21(CTS)</u> approved by the Commissioner of Property and Procurement on <u>September 27, 2021</u> and (which constitute and are hereinafter referred to as the "Contract"), the Government contracted with Contractor to provide <u>Emergency Territorial and Federal Roadside Clearance on the Island of St. Croix,</u> <u>U.S. Virgin Islands</u>; and

WHEREAS, the Supply Contract expires pursuant to its terms on May 31, 2022; and

WHEREAS, the parties desire to amend the Supply Contract, to extend the term of the contract to <u>November 30, 2022</u> subject to the terms and conditions set forth below to ensure uninterrupted services during the hurricane season and natural disasters; and

WHEREAS, the parties desire to amend the Supply Contract, to add a one (1) year renewal option, subject to the terms and conditions set forth below;

**NOW THEREFORE**, for mutual and valuable consideration, the undersigned contracting parties agree to amend the Contract as follows:

#### **TERMS AND CONDITIONS**

1. The Contract, is hereby amended by deleting all existing language contained in Section III and replacing it with language as follows:

This Contract shall commence on <u>June 1, 2021</u>, and shall terminate on <u>November 30</u>, <u>2022</u>, unless mutually extended or terminated by the Parties. The Government in its sole discretion will have the option to extend the services under this Contract for a one-year period commencing <u>December 1, 2022</u> and terminating <u>November 30, 2023</u>. No alterations or variations of the terms of the proposal shall be valid or binding upon the Government unless made in writing and approved by the Government.
