**AMENDMENT No. 1 OF  
PROFESSIONAL SERVICES CONTRACT**

**THIS AMENDMENT** made as of the 20th day of July, 2022 in the Territory of the Virgin Islands, by and between the Government of the Virgin Islands DEPARTMENT OF PROPERTY AND PROCUREMENT, on behalf of the DEPARTMENT OF PUBLIC WORKS (hereinafter referred to as "Government") and WSP USA Inc., formerly known as Parsons Brinckerhoff, Inc. whose address is 4139 Oregon Pike Ephrata PA, 17522(hereinafter referred to as "Contract").

Both parties witness to being duly authorized to execute this agreement and will attest accordingly when and where necessary.

**WITNESSETH**

**WHEREAS**, pursuant to Contract No.P042DPWT19 approved by the Governor on 7/24/2019 "(which is hereinafter referred to as the "Contract")." the Government contracted with the Contractor to provide Architectural and Engineering services to reduce the existing traffic congestion along the segment of Veterans Drive (Route 30) between Kronprindsends Tvaer Gade and W.G. Lewis Lane (formerly Lovers Lane)/ Long Bay Road intersection; and

**WHEREAS**, the Contract expires pursuant to its terms on June 30, 2023; and

**WHEREAS**, "The Government desires to amend the Contract to: (i) include additional services for the design of a Counterfort Wall along the new alignment around the Legislature Building, include a Flushing Study for the proposed lagoon surrounding the Legislature Building and Visualization Services for the preparation of a 2.5D motion simulation; (ii) extend the term by six (6) months; and (iii) increase the compensation by **Three Hundred Seventy-Four Thousand Seven Hundred Ninety-Eight Dollars and Seventy-Eight Cents (\$374,798.78)**

**WHEREAS**, the accomplishment of the services described hereinafter is authorized by Federal Highway Administration (FHWA) under Title 23 U.S.C. 215; and

**NOW, THEREFORE**, for mutual and valuable consideration, the receipt and sufficiency of which is hereby acknowledge, the parties hereto agree as follows:

**TERMS AND CONDITIONS**

1 Paragraph No.1- Services is hereby amended by deleting the existing text contained therein and replacing it with new language as follows:

"The Contractor will provide the services described in Addendum I (Scope of Work) and Addendum IA (Additional Scope of Work) attached hereto and made a part of this Contract."

- 2 Paragraph No.2- Term is hereby amended by deleting the existing text contained therein and replacing it with new language as follows:

"The Term of this Contract shall be from March 1, 2017, to December 31, 2023. Upon the date of execution of this Contract by the Governor of the U.S. Virgin Islands, this Contract shall become effective for the Term set out herein. The Government in its sole discretion shall have the option to extend this Contract for a period of one (1) additional year subject to the same terms noted herein, by providing the Contractor with sixty (60) days written notice of the Government's election to extend."

- 3 Paragraph No.3- Compensation is hereby amended by deleting the text in the first paragraph and replacing it with new language as follows:

"The Government in consideration of the satisfactory performance of services described in Addendum I (Scope of Work) and Addendum IA (Additional Scope of Work) agrees to pay the Contractor a sum not to exceed Three Million Seven Hundred Eighty-Six Thousand Six Hundred Fifty Dollars and Eighty-Four Cents (3,786,650.84) in accordance with the following."

- 4 Paragraph No.3 (2)-Compensation is amended by deleting the existing text contained therein and replacing it with the following language:

"The Government in consideration of the satisfactory performance of the services described in Addendum I (Scope of Work) Tasks, 2 through 7, agrees to pay the Contractor a sum not the exceed Three Million Three Hundred Thirty-One Thousand Two Hundred Twelve and Thirty-Three Cents (\$3,331,212.33) in accordance with the provisions of Addendum II (Compensation) with Addenda IIa, IIb, IIc, and IId. The Government in consideration of satisfactory performance of the services described in Addendum IA (Additional Scope of Work) Tasks 1 through 9, agrees to pay the Contractor a sum not to exceed Three Hundred Seventy-Four Thousand Seven Hundred Ninety-Eight Dollars and Seventy-Eight Cents (\$374,798.78) in accordance with the provisions of Addendum IIA (Additional Compensation)."

- (a) Paragraph No.23- Other Provisions as follows:

Paragraph No.23- Other Provisions is hereby amended by deleting all the text contained therein and replacing it with new language as follows:

"Addenda I, IA, II, IIA, IIa, IIb, IIc, IId, III, IV, and V attached hereto are a part of this Contract and are incorporated herein by reference."

5. Paragraph No.5-Addendum I (Scope of Work) is hereby amending adding Addendum IA (Additional Scope Work) attached hereto as Exhibit A and incorporated by reference.
6. Addendum II (Compensation) is hereby amended by adding Addendum IIA (Additional Compensation) attached hereto as Exhibit B and incorporated by reference.
7. "This Amendment is subject to the approval of the Governor of the Virgin Islands and to the appropriation and availability of funds."


